**Hazard Statement**

(H350) Cancer Hazard. Contains quartz (crystalline silica) which may cause cancer. Risk of cancer depends upon duration and level of exposure to the dust. Not an acute hazard.  
(H332) Prolonged inhalation of dust may cause lung injury. Inhalation of high concentrations of dust may cause mechanical irritation and discomfort of the respiratory tract. Repeated exposure may have chronic effects.

### Section 4 - First Aid Measures

#### First-Aid Measures

<b>Eye Contact</b>	If eye contact occurs, rinse immediately with plenty of water. If irritation persists, seek medical attention.
<b>Skin Contact</b>	If irritation occurs, wash thoroughly with water. If it persists, seek medical attention.
<b>Inhalation</b>	Move victim to fresh air in well ventilated area. If coughing or irritation persists, seek medical attention.
<b>Ingestion</b>	Consult physician and/or obtain competent medical assistance.

#### Symptoms and Effects, both Acute and Delayed

<b>Eye Contact</b>	Prolonged contact with large amounts of dust may cause mechanical irritation.
<b>Skin Contact</b>	Prolonged contact with large amounts of dust may cause mechanical irritation.
<b>Inhalation</b>	Inhalation of high concentrations of dry clay dust may cause mechanical irritation and discomfort. Long term exposure may cause chronic effects (see section 11).
<b>Ingestion</b>	Large quantities ingested may cause gastrointestinal irritation.
<b>Chronic Symptoms</b>	Repeated or prolonged exposure to respirable crystalline silica dust may cause lung damage in the form of silicosis. Symptoms will include shortness of breath, fever fatigue, loss of appetite, chest pain, dry non-productive cough.

## Section 5 - Fire Fighting Measures

<b>General Fire Hazards</b>	Clay mixture in dry or moist form is not flammable and does not support fire. The paper bags or plastic bags and cardboard boxes containing the mixture are flammable.
<b>Extinguishing Media</b>	Use appropriate extinguishing media for surrounding fire.
<b>Chemical hazards from fire</b>	Clay mixture does not contain hazardous decomposition products.
<b>Protective actions and equipment for fire-fighters</b>	Clay mixture and packaging can become slippery when wet. Fire-fighters should wear appropriate protective equipment.

## Section 6 - Accidental Release Measures

<b>Clean-up Methods</b>	If appropriate, use gentle water spray to wet down and minimize dust generation.
<b>Personal Precautions and Personal Protective Equipment</b>	Wear appropriate protective equipment and clothing during clean-up. When dry sweeping use NIOSH approved respirators when dust levels exceed exposure limits.
<b>Environmental Precautions</b>	Clay is a natural mineral product mixture and will not cause adverse effects to the water system other than turbidity from suspended particles.
<b>Emergency procedures &amp; Methods of Containment</b>	There are no emergency procedures required for this mixture. Place dry clay dust in a sealed container for re-use or proper disposal.

<b>Precautions for safe handling</b>	Use proper lifting techniques to avoid physical injury.
<b>Recommendations on the conditions for safe storage</b>	No special storage considerations. Do not store moist clay mixture below freezing point ( $< 0\text{ }^{\circ}\text{C}$ or $< 32^{\circ}\text{F}$ ).

### Engineering Measures

Clay mixture in moist form poses no inhalation health risk. Once clay mixture has dried, there may be dust generated by cleaning and working processes. In the event that dust is generated, use local exhaust ventilation or other engineering controls as required to maintain exposures below applicable occupational exposure limits (TLV).

### Personal Protective Equipment (PPE)

#### Respiratory

Dust is generated when working with dry clay mixture. To minimize exposure to dust and/or crystalline silica, cutting or sanding dry clay products should be conducted with sufficient ventilation. Respirable dust and quartz levels should be monitored regularly. Dust and quartz levels in excess of appropriate exposure limits should be reduced by feasible engineering controls, including (but not limited to) wet sanding, wet suppression, ventilation, and process enclosure. When such controls are not feasible, NIOSH/MSHA approved respirators must be worn in accordance with a respiratory protection program which meets OSHA requirements as set forth at 29 CFR1910.134 and ANSI Z88.2-1080 "Practices for Respiratory Protection". In most cases, a disposable N-95 Particulate Respirator is sufficient.

#### Eyes

Use of NIOSH/OSHA approved safety glasses with side shields is recommended. Face shields should also be used when dry sawing clay products. Wear tight fitting dust goggles when excessively (visible) dusty conditions are present or are anticipated. NIOSH recommends that contact lenses not be worn when working with crystalline silica dust.

#### Skin and Body

Protective Clothing is not essential. Use gloves and/or protective clothing if abrasion or allergic reactions are experienced.

## Section 11 - Toxicological Information

**Primary Route of Exposure:** Skin, Eye Contact, Inhalation and Ingestion

### Specific Organ Toxicity - Single Exposure

Target organs include ears, skin, respiratory system, and gastrointestinal tract.

### Specific Organ Toxicity - Repeated Exposure

Causes damage to eyes, skin, respiratory system, and gastrointestinal tract through prolonged or repeated exposure.

### Acute Short-Term Exposure Effects

May cause eye irritation, skin irritation, respiratory tract irritation, and gastrointestinal tract irritation. Inhalation of high concentrations of dry clay dust may cause mechanical irritation and discomfort. Long term exposure may cause chronic effects.

### Chronic Long Term Exposure Effects

Silica has been classified by OSHA as a human lung carcinogen. Repeated or prolonged exposure of respirable crystalline silica dust may cause lung damage in the form of silicosis.

Effects of silicosis include bronchitis/chronic obstructive pulmonary disorder, increased susceptibility to tuberculosis, scleroderma (a disease affecting skin, blood vessels, joints and skeletal muscles), and possible renal disease. Acute silicosis can be fatal.

### Related Symptoms

Symptoms will include shortness of breath, fever, fatigue, loss of appetite, chest pain, dry non-productive cough.

### Medical Conditions Aggravated by Exposure:

Individuals with pre-existing allergies, eye disorders, skin disorders, respiratory disorders and/or gastrointestinal disorders may have increased susceptibility to the effects of exposure.
